

A message from our **Chairperson** & **CEO**

James Kennedy Chairperson

At the NSAI, our dedicated team makes a difference every day by supporting innovation for a safer, better, and sustainable future.

In 2022, we marked 25 years since our establishment through the launch of our 2022 – 2026 Strategic Plan, which, at its core, reflects key government and EU priorities.

Through our contributions to the Climate Action Plan, Housing for All and the National Digital Strategy, we are increasingly seeing the results of our engagement across government in terms of the value and impact of standards developments.

Recently published government strategies* all call out the contribution of standards and standards development in terms of supporting Irish enterprise and research.

2022 was a seminal year for standards; since its publication in February 2022, the European Standardisation Strategy has brought a significant and renewed priority and focus to European standardisation activities. Standardisation is on the agenda of policymakers at the highest levels.

At a national level, over 300,000 users accessed standards via our online catalogue in 2022. Our catalogue now exceeds 28,500 different standards,

our capabilities to become a designated Certification Body under the Cybersecurity Act, to support Ireland fulfil its obligations under these new regulations. Last year, we also developed a new European partnership with A4CEF to implement cybersecurity standards through certification.

In the US, 2022 proved to be a fruitful year for NSAI Inc. There was a significant increase in the number of medical device sites and management system certification sites that were registered across all programmes.

Meanwhile in the UK market, NSAI Certification UK successfully passed its assessment audits for its work under the UKCA mark for Construction, Measuring Instruments and Non-Automatic Weighing Instruments.

Our National Metrology Laboratory (NML) experienced significant demand for its calibration services during 2022. By the end of the year, NML staff completed over 5000 calibrations of varying complexity and covered a wide range of industries. This work has provided essential traceability for Irish industry and has been performed to the highest quality.

Ongoing legal metrology inspections took place throughout 2022. The division carried out over 22,000 instrument inspections and nearly 8,000 trader visits in a calendar year. The team tested all taximeter programmes in record time, in support of the introduction of the new 2022 taxi fare.

NSAI Medical Devices ended a busy and a very successful year with the approval of several medical devices which are critical for patient safety. NSAI was also recommended to become designated as a notified body under In Vitro Diagnostic Medical Devices Regulation (EU) 2017/746, making us one of only ten notified bodies in Europe.

Our work in Business Excellence continued to support Ireland's SMEs, especially in such critical areas as digital transformation, information security, and cybersecurity. We have been working hard to develop As we look back over the last year, and indeed over the last twenty-five years of NSAI, it is vital for us to build upon these highlights ensuring that we continue to drive a progressive agenda on issues like future jobs, housing for all, climate change, sustainability, and standards for the future.



2022 was an important year of developing with the launch of our <u>new strategic plan 2022</u> shape a safer, better, and sustainable full.

NSAI strategic goals showcase the reach and contribution within the organisation which, span and the national lines include the growth of SMEs, climate and meeting government's Housing for All policy.

In one of NSAI's key strategic projects, *Supporting National Economic Growth and SMEs*, self-assessment tools for key management system standards (ISO 9001 – quality management systems and ISO 27001 – information security management systems) were developed for use by Irish SMEs.

Under **Housing for All**, NSAI offered certifications on the construction stage and sign-off on modern methods of construction (MMC) products as well as building system installation compliance under building regulations. NSAI also published the guide to Agrément certification for modern methods of construction, under Housing for All.

Through the provision of technical infrastructure services for emerging technologies, low carbon and modern methods of construction, climate adaptation, carbon capture, and use of alternative fuels, NSAI fully supported European and national policy delivery under the *Climate Action Plan*. NSAI also continued offering businesses a carbon footprint auditing and verification service and a range of ISO energy and environmental schemes.
