





- i. Non Automatic Weighing Instruments - A fee of €198.00 per hour or part thereof to the nearest 1/4 hour will be levied on the calibration provider on each occasion when following the commencement of Verification Test Procedure a calibration adjustment is undertaken such that the ongoing Verification Procedure must be abandoned and re-commenced.

**3 Conditions**

- i. Imperial Denominations - On the verification and stamping of an imperial weight, measure, weighing or measuring instrument, the fee shall be that which is prescribed in this Schedule with respect to the equivalent in metric capacity.
- ii. Multi-interval/multi range - Where an instrument has two sets of graduations of different form, double the appropriate fee shall be payable.

**4 Rejection Fees**

Where in an examination for verification and stamping of weights and measures and weighing and measuring instruments, weights, measures or instruments are found to be defective and are rejected, a fee shall be payable equal in a amount to that which would have been chargeable if such weights, measures or instruments had been found to be free of defects.

**5 Travel & Transport Expenses**

Where any weighing or measuring instrument is required to be verified in situ, the cost of transport of the required standards and the travelling expenses of the inspector between the nearest LM Regional Verification Centre and the place at which the verification is made shall be payable in addition to the appropriate fee under this Schedule. Where Capacity Measures for use in the Licensed Trade are verified in a premises other than that of the Legal Metrology Service, the travel and subsistence expenses associated with such exercises shall also be payable by the applicant.

**6 Value Added Tax**

All fees are subject to VAT @ 23%.
