1 Introduction

NSAI/ETC/TC 1 is the national mirror committee responsible for coordinating Ireland's engagement with the IEC/TC 61 and CLC/TC 61 - Safety of household and similar electrical appliances, and IEC/TC 59 and CLC/TC 59X - Performance of household and similar electrical appliances.

2 Scope of TC

NSAI/ETC/TC 1 is responsible for the Irish contribution to standards in the fields of safety and performance of electrical household appliances, including those used on commercial premises and on farms. The committee participates in the work of IEC/TC 59 and CLC/TC 59X which provide International and European Standards in the area of Performance of household and similar electrical appliances, and IEC/TC 61 and CLC/TC 61 which provide International and European Standards in the area of Safety of household and similar electrical appliances.



ETC TC1 monitors and advises in relation to NSAI's position on the work being undertaken by CENELEC and IEC in the areas of Safety of Household appliances, and Performance of Household appliances.

ETC/ TC 1 members contributed to the development of international standards on Electrical air cleaners for households under IEC/SC 59N

4.3 Regulatory Development/Update

The number of household and similar appliances utilising IoT technology for a variety of purposes such as remote diagnostics and performance monitoring continued to increase in 2023. As a result, 2023 saw increased awareness of new and emerging areas of horizontal interest, such as Artificial intelligence and Cybersecurity, and the relevant pieces of European legislation in this space such as the A.I. Act, the Cyber Resilience Act, and the Radio Equipment Directive Delegated Act.

The General Product Safety Regulation entered into force on 12th June 2023 and will replace the older General Product Safety Directive from 13th December 2024.

The Ecodesign for Sustainable Products Regulation is another piece of "in-progress" EU legislation which will replace the existing Ecodesign directive and therefore likely have an impact on the deliverables of CLC/TC 59X

A new Standardisation request (SReq) from the European commission on Tumble dryers was progressed in 2023. This new SReqs cited a number of standards from CLC/TC 59X with a requirement to deliver revised standards for harmonisation against the Ecodesign and Ecolabelling directives. Members of NSAI/ETC/TC 1 were given the opportunity to review the draft text and provide feedback to NSAI. Input from NSAI on the SReq was shared with the Department of Enterprise, Trade and Employment, and also to the CEN/CLC Technical board.

ETC TC1 should remain aware of the following Regulations and Directives and related reviews;

- Directive 2001/95/EC General Product Safety Directive (GPSD)
- Directive 2014/30/EU Electromagnetic Compatibility (EMC)
- Directive 2014/35/EU The Low Voltage Directive (LVD)
- Directive 2014/53/EU Radio Equipment Directive (RED)
- Directive 2009/125/EC Establishing a framework for the setting of ecodesign requirements for energy-related products
- Regulation (EC) No 66/2010 of the European Parliament and of the Council of 25 November 2009 on the EU Ecolabel
- Directive 2009/48/EC The Toy Safety Directive
- Directive 2006/42/EC The Machinery Directive

In addition to the above, the large number of Regulations/Delegated Regulations for different product groups for the implementation of the Ecodesign and Energy Labelling legislation.
