#### **Alarm Systems**

## Scope

To prepare European standards in the field of alarm and intruder systems.

Alarm systems encompasses detection, signalling, and monitoring systems for the protection of persons and property, including elements used in such systems. The scope includes in particular intruder and hold-up alarm systems, access control systems, periphery protection systems, combined alarm and fire alarm systems, social alarm systems, CCTV systems, and other monitoring and surveillance systems related to security applications, as well as associated and dedicated transmission and communication systems. The Technical Specifications and Standards also detail methods and tests for compatibility assessment of system components.

## 1.2. Irish Industry/Sector

#### Review of the Year 2019

The Committee met twice in 2019 and a number of the committee members attend WG 01 and WG 03 meetings throughout the year. During 2019 the committee met in April and November.

The next CLC TC79 Plenary Meeting will take place in Frankfurt, Germany in October 2020.

The Standard Recommendations S.R. 40 (Electronic Security Services - Intruder alarm, access control and CCTV systems) and S.R. 41 (Electronic Security Services - Remote services) have now been withdrawn as these have been replaced by documents produced by the PSA (Private Security Authority) as follows:

- S.R. 40 has now been replaced by PSA Licensing Requirements Security Service Providers (PSA74:2018).
- S.R. 41 has now been replaced by PSA Licensing Requirements CCTV Monitoring and Alarm Monitoring Centres (PSA33:2014).

## 6. Programme for Coming Year 2020

The committee will be focusing on three standards that are due for review:

EN 50131-3:2009 Alarm systems - Intrusion and hold-up systems - Part 3: Control and indicating equipment.

EN 50131-10:2014 Alarm systems - Intrusion and hold-up systems - Part 10: Application specific requirements for Supervised Premises Transceiver (SPT).

EN 50136-3:2013 Alarm systems – Alarm transmission systems and equipment - Part 3: Requirements for Receiving Centre Transceiver (RCT).

Also, with the imminent publication of EN 50131-1:2006/A3:2020 Alarm systems - Intrusion and hold-up systems - Part 1: System requirements, CLC/TC 79/WG1 will start work on a new revision of the standard.

Finally, CLC/TC 79/WG 11 will start work on EN 50131-5-3:2017 Alarm systems - Intrusion systems - Part 5-3: Requirements for interconnections equipment using radio frequency techniques about modernising the standard to remove frequency restrictions.

It is intended to hold at least two committee meetings during 2020 similar to 2019.

The next plenary meeting of CLC TC 79 to be held in Frankfurt, Germany in October 2020 shall also be attended and it is planned to attend WG 1 " Intruder & hold-up alarm systems" and WG 3 " Control & indicating equipment, power supply for intruder alarm systems" meetings whenever possible.
