### 1 Chairman's Statement

NSAI

The construction sector in Ireland experienced a very challenging year in 2020, with the devastating effects on the industry of the global pandemic COVID – 19, the implications of Brexit, concerns around the review of the Construction Products Regulation (Regulation EU 305/2011) and the ambiguities surrounding the launch by the European Commission CPR Acquis process.

The NSAI Roads Standards Committee (RSC) experts adapted very well to the changing operational needs due to COVID – 19 as national and international standardisation activities continued in the virtual environment.

The RSC met in July 2020, the agenda included activity reports from the Working Groups, an update on the CPR review and a presentation on the work of Construction Standards Consultative Committee in the development and launch of the NSAI Construction Sector Standardisation Programme to 2021.

The RSC Members had a busy year participating in national and international standards development work online in 2020. The main national work items were the continued development of the revision of S.R. 18 Irish National guidance to EN 13139:2002 Aggregates for mortar by the Aggregates Panel in conjunction with the Concrete Standards Consultative committee, and the continued development of Irish Standard I.S. 844 Transportation and Installation of Bituminous Materials for roads and other paved areas, by the Asphalt WG.

The CPR Acquis (i.e., harmonised standards, the European assessment documents and the legal acts of the European Commission) a parallel and separate process to the CPR review was launched by the European Commission in 2020. Information on this process was circulated to the RSC and Working Groups and the DHLGH gave presentations to WGs of the RSC on the CPR Acquis programme and the support provided by NSAI Standards to this programme.

Thank you to all the experts in the Roads Standards Committee technical bodies (SCs, WGs) for your continued commitment to standards development during 2020 and a particular thank you to the Chairs.

# 2 Introduction

NSAI/TC 17 Roads Standards Committee (RSC) is a national Consultative Committee which advises the NSAI on standards for roads, materials and equipment. There are national technical bodies (WGs, SCs) for different aspects of roads standards which report into the RSC.

NSAI facilitates national experts to participate in international standards development work in the area of roads standards. The national technical bodies "mirror" the relevant CEN (European Committee for Standardization) technical committees, see 4.1 for the structure of the Roads Standards Committee and the relevant CEN technical bodies mirrored at national level.

The NSAI Roads Standards committee technical bodies monitor, comment and vote on draft standards being developed at CEN level and are also responsible for developing indigenous Irish Standards and guidance documents to the CEN standards adopted as Irish Standards on publication. A number of Irish experts on the Roads Standards Committee also participate as Members of relevant CEN technical committees.

Due to the COVID – 19 pandemic national and international work progressed online in 2020, see section 5 for a summary of national and CEN meetings attended by Irish experts in 2020.


# 3 Scope of TC

- 2. To draft appropriate documentation including Standards, Codes of Practice, Amendments, and relevant guidance documents.
- 3. To advise NSAI on how to vote on draft European and International Standards.
- 4. To ensure that relevant interested parties are consulted in the drafting of Standards, Codes of Practice, guidance documents and on voting on draft European and International Standards where applicable.
- 5. To liaise with similar bodies in other EU countries and in particular CEN (European Committee for Standardisation) and ISO (International Organisation for Standardisation), where relevant.
