1 Introduction

In 2019 the NSAI/TC 033 Crane consultative committee achieved a significant milestone with the publication of I.S. 360:2019 - Code of Practice: Safe Use of Cranes in the Construction Industry. The revision was deemed necessary to reflect the changes in Irish health and safety legislation in recent years and to provide guidance on the trends, practices and equipment currently used for lifting operations in the construction industry in Ireland. The extensive revision has resulted in the publication of a substantial document in under 24 months, which is a significant achievement in the development of a standard.

The committee also monitors work at International level (CEN and ISO) and since the reestablishment of the committee, members have become active participants in a number of ISO and CEN working groups, where previously Ireland were effectively observers.



2 Scope of TC

NSAI/TC 033 is predominantly responsible for maintaining and developing the National codes of practice for the safe use of cranes and tower cranes, principally in the construction industry, but which can be applied whenever lifting equipment with a lifting capacity in excess of four tonne is being used. It is also responsible for monitoring the work of CEN/TC 147 – Cranes - Safety and as well as the work of a number of ISO/TC 96 sub committees (SC 6 and SC 9).



4 Summary of 2019 Activities

4.1 National

2019 saw the continued development of the revision of I.S. 360 - Code of Practice: Safe Use of Cranes in the Construction Industry. The public enquiry of the draft was launched in the spring of 2019 and the NSAI/TC 33/SC 1 committee met in June for a comment review meeting and to approve the draft for publication. I.S. 360:2019 was published in December 2019 after approval from the NSAI Board.

Members of SC 4-Bridge and gantry cranes monitored International work within CEN/TC 147/WG 14 and ISO/TC 96/SC 9.

4.1.2 National Work

The main activity of NSAI/TC 033 has been the development of National documents such as I.S. 360:2019 and I.S. 361:2013 - Code of practice for safe use of tower cranes and self-erecting cranes. As mentioned in the introduction the publication of the new I.S. 360 code of practice within 24 months is quite a significant achievement for the committee and demonstrated the common goal of industry and all its stakeholders to develop a document which reflects current practice on sites.



The need to promote the activities of the committee especially in relation to the publication of I.S 360:2019 and the upcoming revision of I.S 361 which was highlighted in the review of the work programme of the NSAI/TC 033 committee in 2018 still needs to be adequately addressed. Training of members in the standardisation process is required and a need for new members to support current members, in particular at International level is still also required.

4.2 International

4.2.1 International Work

Due to a number of years of inactivity Irelands was due to be recategorized as an O member of ISO/TC 96/SC 9. However in 2019, P membership of ISO TC 96/SC 9 as retained as Irish experts engagement with the committee was reestablished. Monitoring and balloting on ISO/TC 96/SC 9 work has also increased and it is hoped that this activity will be maintained in 2020.

4.2.2 International Standards Reviewed

The committee did not carry out any systematic reviews of current standards in 2019.
