1 Introduction

In 2021 the NSAI Crane committee TC 033, under Subcommittee 2 (SC 2) began the process of revising I.S. 361:2013 - Code of practice for the safe use of tower cranes and self-erecting cranes following publication of I.S. 360:2019 - Code of Practice: Safe Use of Cranes in the Construction Industry.

The membership of SC 2 was expanded to ensure a balanced representation of stakeholders.

The committee and its subcommittees also continued to monitor work at international and regional levels (CEN and ISO) with some active participants in a number of ISO and CEN working groups.

2 Scope of TC

NSAI/TC 033 is predominantly responsible for maintaining and developing the National codes of practice for the safe use of cranes and tower cranes, principally in the construction industry, but which can be applied whenever lifting equipment with a lifting capacity in excess of four tonne is being used. It is also responsible for monitoring the work of CEN/TC 147 – Cranes – Safety, as well as the work of a number of ISO/TC 96 sub committees (SC 6 and SC 9).


