1 Introduction

NSAI/TC 61 – Chimneys – is the Irish National mirror committee to CEN/TC 166, which produces European standards in the field of Chimneys and vents used for conveying the products of combustion to the outside atmosphere.

CEN/TC 166 has published documents that are cited in the Technical Guidance Documents to the Irish Building Regulations.

NSAI/TC 61 is an Electronic Committee (eCommittee).

eCommittees are bodies established by NSAI to facilitate individual experts or associations to monitor and participate in international work, however there is minimal national interest to justify the establishment of a technical committee. eCommittees do not meet.



The NSAI Chimney committee supports the development of international standards in the area of Chimneys.
